

THE FOLLOWING TERMS AND CONDITIONS APPLY FOR TICKETS PURCHASED FOR
THE THINK.BDPST CONFERENCE:

1. Customer understands and accepts that the tickets are non-transferable and undertakes that he or she shall not give it to third parties as each customer receives a personalised voucher upon purchase. The resale of tickets is forbidden. The Antall József Knowledge Centre has the right to cancel tickets that have been resold.
2. No refund on tickets will be made under any circumstances except in case of event cancellation and vis maior (including but not limited to war, revolution, natural disaster, or not foreseeable political events).
3. Customers are asked to show their vouchers in order to receive their badges. Badges can be collected on the spot from 4:30pm onward on 29 March 2017, 8am on 30 March 2017, and 8:15am 31 March 2017.
4. A third party will not be allowed to collect the ticket of a customer unless authorised in writing to do so.
5. The Antall József Knowledge Centre may refuse admission to any persons whose conduct is disorderly or unbecoming.
6. Customer understands and accepts that think.BDPST is the trademark of the Antall József Knowledge Centre.
7. Customer understands and accepts that no audio or video recording is allowed during the conference unless having the written consent of the statutory representative of the Knowledge Centre. Although the event is open to the press, performers and speakers might have an objection against being photographed. Guests, therefore, are kindly asked to refrain from taking pictures.
8. The conference will receive high publicity and will be recorded in its entirety. With attending the conference, the customer agrees to have his or her image reused in promotional photographs or his or her likeness appear in any live or recorded video display.

10. The Knowledge Centre may cancel, interrupt, or stop the event in case of foul weather, dangerous situations or any other circumstance beyond its control.
